Confirmation of Neighbourhood Plan for Bledlow-cum-Saunderton Parish

Further to our meeting on 10th July, I am writing to confirm that the Bledlow-cum-Saunderton Parish Council wish to progress with a neighbourhood plan for the entire Parish. The reasons for this are as stated in my letter of 10th June to Penelope Tollitt.

To remove any possible ambiguity, I attach the plan showing the parish boundaries which you kindly sent to me earlier.

We understand that you intend to start the six week consultation regarding the area to be covered towards the end of August. We wish to avoid any further delay; we already have a draft project plan which we will share with you once our initial working party has reviewed this and the projected timescales have been discussed at the next meeting of the Parish Council on Thursday 6th August. As I mentioned when we met, we favour following an aggressive timeline and look forward to receiving support from Wycombe District Council and others in a timely manner. A very high proportion of the parish's population has demonstrated their concern re planning over the past few years, and I wish to harness this before interest wanes.

Our existing working party will be set up as a formal sub-committee of the Parish Council, subject only to the Councillors agreement, at our next meeting. We are already in the process of recruiting a panel of advisors from within the parish, and also assembling a short list of Planning Consultants to fill in any remaining gaps.

We look forward to Wycombe District Council's cooperation and timely support as we go forward.


